This agreement is governed by the laws of the **Republic of South Africa**. Disputes shall be resolved via **mediation**, then the **Magistrate's Court** (if claim < R 300,000) or **High Court**.

10. CPA COOLING-OFF (if applicable)

If this agreement was concluded **away from Lessor's premises** (e.g., online/ phone), Lessee may cancel within **5 business days** with written notice and pay a reasonable cancellation penalty (max 10% of rental value).
